## **Indemnification**

- <u>1. - 2. Acceptable Conduct. Participant agrees and acknowledges he/she will participate in all activities in a careful, safe, and conscientious manner. Participant agrees to, at all times, observe and adhere to any rules and guidelines posted or stated by Hand In Hand Outdoors, Inc., and any applicable laws or regulations of the State of Utah.
